Safety Precautions

- Be sure to save the packing carton in the unlikely event the unit may have to be returned for service
- Do not spill water or other liquids into or on to your fogger. Be sure that all the fog fluid is kept inside the fluid reservoir
- Be sure that the local power outlet match that or the required voltage for your fog machine
- Do not remove the top cover under any conditions. There are no user serviceable parts inside
- Disconnect the unit's main power when left unused for long periods of time
- Never connect this unit to a dimmer pack
- · Do not attempt to operate this unit, if it becomes damaged in anyway
- Never operate this unit when it's cover is removed
- To reduce the risk of electrical shock or fire, do not expose this unit rain or moisture
- Do not attempt to operate this unit if the power cord has been frayed or broken. Do not attempt to remove or break off the ground prong from the electrical cord. This prong is used to reduce the risk of electrical shock and fire in case of an internal short
- Disconnect from main power before making any type of connection
- Never block the ventilation holes. Always be sure to mount this unit in an area that will allow proper ventilation. Allow about 6" (15cm) between this device and a wall
- This unit is intended for indoor use only, use of this product outdoors voids all warranties
- When storing for long periods of time, please follow the instructions on page 6 for proper maintenance and storage.
- Always mount this unit in a safe and stable matter
- Please route your power cord out of the way of foot traffic. Power cords should be routed so they are not likely to be walked on, pinched by items placed upon or against them

VF Volcano

The new VF Volcano fog machine features a fog juice level sensor. When fog fluid resevoir has enough fog juice the LED will glow, when the fog juice level is low, the LED will flash. When the fog juice level reaches a lower level, a bult-in sensor inside the reservoir will automatically shut off the pump. This will greatly expand the life of the pump. The new VF Volcano fog machine includes a revolutionary new heating element that has been specially designed to prevent excessive particle build up that can cause premature fogger failure. The fog machine also includes a wireless remote control, that can control LEDs and fog output.

Set-Up

- 1. Open the shipping carton and carefully remove the unit from the shipping carton.
- 2. Be sure to remove all the packing material especially around the nozzle.
- Set the fog machine on a flat dry surface. Fill the fog fluid reservoir with American DJ brand fog juice only and then tighten the cap.
 NOTE: The glowing red LED indicates that the reservoir has enough fog fluid. If the red LED begins to flash, this indicates that the machine is running low on fog fluid.
- 4. Plug the unit in to a matching power supply. Wait for the fogger to reach normal operating temperature. When it has reached the operating temperature, and is ready to fog, the green LED located on the rear of the unit will glow.
- 5. Either press the fog button located on the rear or press one of the remote buttons to emit fog. See the next page for remote operating instructions.

Wireless Remote Operation

Always be sure to maintain an adequate supply of American DJ Brand Fog Juice in the fluid reservoir. Running the fog machine dry will cause pump failure and or clogging. This is the largest cause of failure in fog and haze machines. Only American DJ Fog Juice is recommended and not all fog juice is created equal.

Wireless Remote Operation: Start by plugging in the machine. The unit has a warm up time of about six (6) minutes. After the unit has warmed up, a GREEN LED located at the rear of the unit will light indicating the unit is ready to emit fog. To emit fog, simply press 1 of the 8 buttons on the wireless remote. If the GREEN LED is on and fog does not come out after holding the button down for 30 seconds, check the fluid tank and make sure you have enough fog juice.

Button 1 - Fog + Red LEDs Button 2 - Fog + Green LEDs Button 3 - Fog + Blue LEDs Button 4 - Fog + Red, Green, & Blue LEDs Button 5 - Fog + Red & Green LEDs Button 6 - Fog + Red & Blue LEDs Button 7 - Fog + Green & Blue LEDs Button 8 - Fog + Red, Green, & Blue LEDs + Strobing

Disconnect the unit from its power source. Remove the power cord from the unit. Once the cord has been removed, you will find that the fuse holder is located inside the power socket. Insert a flat-head screw driver into the power socket and gently pry out the fuse holder. Remove the bad fuse and replace with a new one. The fuse holder also has a holder for a spare fuse.

VF Volcano Proper Storage and Maintenance

When storing your fog machine be sure to store it in a cool area. Cover the machine so that dust does not build up on the unit. When storing the machine for long periods of time, it is highly advised to at least run the machine every 3-4 months. Long periods of inactivity can severly shorten the life of your machine. Only run water based fog juice through your machine. Never run plain water, vinegar, or any other liquid solution through your machine. Running anything other then water based fog juice will severly damage your machine.

Warranty Registration

The VF Volcano fog machine carries a one year (365 days) limited warranty. Please fill out the enclosed warranty card to validate your purchase. All returned service items whether under warranty or not, must be freight pre-paid and accompany a return authorization (R.A.) number. The R.A. number must be clearly written on the outside of the return package. A brief description of the problem as well as the R.A. number must also be written down on a piece of paper and included in the shipping container. If the unit is under warranty, you must provide a copy of your proof of purchase invoice. You may obtain a R.A. number by contacting customer support at (800) 322-6337.

Trouble Shooting

If you experience low fog output, pump noise, or no fog output at all, disconnect and discontinue use immediately. Do not attempt to continue pushing the remote control's activation button as this may damage the fog machine. Check the fluid level, the external fuse, remote connection, and be sure the wall outlet is sending power. If all of the above appears to be okay, and the unit fails to operate correctly, the unit will require service. Please contact ADJ Products, LLC.
